Producers should encourage a diversity of character images, abandon stereotypes about specific body types, and avoid stereotyping specific physical features with certain personality traits to avoid exacerbating society's stereotyped perceptions of bodies.

3.2 Breakthrough traditional aesthetic standards

Film creators can advocate multiple aesthetic values and expand audiences' perception of beauty by presenting beauty of different races, ages, genders and cultural backgrounds. Films should pursue diverse aesthetic standards, so that audiences can see different types of beauty in films, so as to free their aesthetic cognition from traditional limitations. Emphasizing the importance of inner qualities such as personality charm, intelligence and emotion helps to encourage audiences to pay more attention to an individual's inner value, rather than just being limited to the superficial appearance.
